proper nutrition, exercise, and a healthy domain.

Seller shall not be held responsible for the development of non-genetically derived faults,
diseases, or disorders, which are due to the Buyer's negligence, abuse and/or disregard
of proper care methods for purchased puppy(s).

A health record of all immunizations and/or worming will be provided by the Seller. The
Buyer agrees to take purchased puppy(s) to a licensed veterinarian of their choice
within 3-4 days after transfer of puppy(s) from Seller to Buyer for a physical examination.

Should puppy(s)/dog be determined to be ill, the dog may, upon a signed written
diagnosis from said licensed veterinarian, be returned for purchase price refund. Seller
will buy the puppy back from the Buyer for the original amount which is \$_____.

No refunds will be given until the puppy in question is returned. And no refunds will be
given, and the puppy will not be taken back without a health examination paper signed
by your licensed veterinarian stating the specific health issue(s) found that deem the

puppy unhealthy. The Seller assumes absolutely no responsibility for fees associated with caring for the puppy(s) in question.

** One year health guarantee is applicable against genetic defects and terminal health defects that are in writing from a licensed veterinarian that describes in detail any/all defects that deems contracted puppy(s) is unfit for "standard quality of life" expectancy.

The guarantee does not cover the development of non-genetically derived faults, diseases, or disorders, which are due to the Buyer's negligence, abuse and/or disregard of proper care methods for purchased puppy(s). ***** Health guarantee should Buyer chooses to use a 3rd party transport service shall be amended to an 11 month guarantee that starts 15 days after the Buyer has received the purchased puppy from hired transport contractor. Should anything happen to the Purchased puppy during transport or within the above stated 15-day period from delivery, Seller assumes NO fiscal responsibility or obligation to Buyer for refund or reparation***.**

** HEALTH CERTIFICATE: Seller states that this/these puppy(s) is to the best of their knowledge, healthy at the time of sale. General health information will be provided verbally by the Seller, which includes information on diet, immunizations, worming, bathing, and any other services provided for puppy(s) mental and physical health at time of sale. Puppy Pickup

This amount will be added to the total price of the purchased puppy and will be due in full to the Seller from the Buyer before purchased puppy is released to the Buyer.
